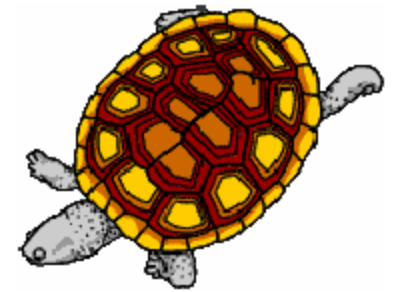
Adventure Day Checklist

A Day of Adventure

The Friends of Pool 9 and the resource agencies that work together to manage the River have teamed up once again to take you out on the river in chartered boats for a day of Tom Sawyer and Huck Finn-like adventure.

We will investigate a bald eagle nest, pollywog (swim) for mussels, seine for fish, search for frogs and turtles, collect aquatic bugs and critters, learn about the floodplain forest plants and animals, and eat a picnic lunch on a scenic Mississippi River island.

The entire event is free!

Who can participate?

The program is designed for students ages 5 to 17. In order to participate, all youth must be accompanied by a parent or adult leader. No more than 4 youth per adult. Sorry no children under the age of 5 will be allowed to participate.

All participants will be provided a Coast Guard approved personal flotation device (life jacket) to be worn at all times when near the water.
